(1) My Way Holdings, LLC reserves the right to cancel this application for stable space in payment of any nomination or eligibility fee for any stakes race shall entitle a horse to stabling at Sunland Park. (8) My Way Holdings, whole or in part, or to refuse the acceptance of any entry in any race at any time for any reason or cause and without notice to the undersigned. (2) The undersigned agrees: (a) To abide by all rules, regulations and policies of My Way Holdings, LLC pertaining to stabling, occupancy and the use of premises at Sunland Park, including rules and regulations contained in the Sunland Park Condition compensation to anyone. Entries will be accepted only on the condition that if requested by My Way Holdings, LLC, the owner, the Book and Horsemen's Guide. SUNLAND PARK SCREENING RULES FOR THE 2021-2022 RACING SEASON

- 1. No two year olds thoroughbreds (foals of 2020) will be allowed to occupy stall space.
- 2. No maiden quarter horses older than four years old. No maiden thoroughbreds older than seven years old.
- 3. Any horse placed on the poor performance list twice during the meet will be ineligible to start and must be removed from the grounds.
- 4. Any horse (winners) that has started for a claiming price of less than \$3,000 for eligibility: must have finished first, second, third, or fourth for \$3,000 claiming or higher since last starting for less than \$3,000 claiming. Maidens that have started for a maiden claiming price of less than \$5,000 for eligibility: must finish first, second, third or fourth for maiden \$5,000 claiming or higher since last starting for less than maiden \$5,000 claiming.
- 5. Minimum claiming price is \$5,000.

POLICIES FOR THE 2021-2022 RACING SEASON STALL APPROVALS

- 1. The Application does not become a binding Stall License Agreement ("License") until signed on behalf of Sunland Park Racetrack & Casino by its Racing Secretary or other authorized agent, and shall remain revocable at the sole discretion of Sunland Park Racetrack & Casino at all times.
- 2. Falsification of any information in this stall application may result in denial, cancellation or revocation of this application and any license resulting here from.
- 3. If the trainer has not bedded assigned stalls or made arrangements with management to show intent of occupying stalls, the stalls will be reassigned after the first entry day.
- 4. Access to the Sunland Park backstretch shall be restricted until all written consents are received permitting the simulcast export of the 2021-22 Sunland Park race meet under the Interstate Horse Racing Act of 1978.
- 5. No mandatory stall limits; each track will allocate number of stalls at their discretion.
- 6. In slips and out slips will be required on all horses.
- 7. Stalls will be allocated based on balance of application and quality of past performances supplied with application. Prior participation and previous rulings of applicant will also be considered, along with any other information deemed relevant by the Stall Committee.
- 8. All applications will include past performances of all horses and current license of trainer applying.
- 9. New Mexico Breds on each application shall have preference over horses of comparable quality.
- 10. Poor performance standards will be enforced at the current meet for a horse who runs at the bottom claiming price in their last four starts and does not place first, second, third, or fourth at the discretion of the Racing Secretary and Stewards.
