
The next NMHBA board meeting is scheduled for March 26, 2022 at 2:00 pm at Sunland Park.

WISH BIGG

Wish Bigg, a gelded son of Big Daddy Cartel trained by James Gonzales III for owner Sebastian Gonzales, scored his first career stakes win in Saturday's 400-yard, \$100,000 New Mexico Horse Breeders' Association Stakes (RG2) for state-bred 3-year-old Quarter Horses. Mario Delgado rode Wish Bigg, who banked the \$60,000 winner's share of the purse.



New Mexican Spring Futurity Qualifiers



JESSES WISH

The field is set for the April 3, \$313,030 New Mexican Spring Futurity (RG2) for state-bred 2-year-old Quarter Horses at Sunland Park.

Jesses Wish (pictured), a son of Jesse James Jr racing for Javier M.

Chavez and Heysol Howlet, set the fastest qualifying time with his 1

3/4-length victory in the sixth of eight trials on Saturday. Ridden by Mario Delgado for trainer James Gonzales III, Jesses Wish covered 300 yards in :15.292 and posted a 95 speed index.

Jesses Wish was bred by Mac and Janis Murray's MJ Farms at Veguita, New Mexico, and he was purchased as a yearling for \$50,000 at last year's New Mexico-Bred Sale at Ruidoso Downs. The bay gelding is out of Wish You Had One To, a winning and multiple graded stakes placed Stel Corona mare, and he is a half brother to Wish Bigg, a Big Daddy Cartel gelding who won Saturday's \$100,000 New Mexico Horse Breeders' Association Stakes (RG2) for state-bred 3-year-olds at Sunland Park.

Second-fastest qualifier Mr Tres Effort won the seventh heat by 1 1/2 lengths in :15.473. Luis Flores-Garcia rode the homebred son of the Feature Mr Jess stallion TF Featured Effort for owner Carlos F. Paez and trainer Eric Valenzuela.

Mr Tres Effort is out of Beyond 15, a winning daughter of the Strawfly Special stallion Desirio and a finalist in the 2015 Four Corners Futurity at SunRay Park.

Major Game, the third-fastest qualifier, made his debut with a twolength victory in the eighth trial. Trained by Eric Valenzuela for owners Jamie Perez, Andres Estrada, and J. Santos Espinoza, the chestnut son of the Walk Thru Fire stallion Gronkowski stopped the timer in :15.503 under jockey Sergio Becerra Jr.

Major Game was bred by Mike Abraham. The colt is out of A Major Chamisa, an unraced homebred daughter of the Rime stallion Major Rime. His second dam, the winning Chicks A Blazin mare Chicks Chamisa, foaled two full graded stakes winning sisters to A Major Chamisa — Rime Has A Chick and Me Chickie — and Sixy Chamisa, a half sister to A Major Chamisa who won the '09 New Mexico Cup Futurity (RG2) at Zia Park and New Mexico Breeders' Futurity (RG2) at SunRay Park.

All 69 of the 2-year-olds entered in Friday's trials were making their first career starts.




For any nominating and sustaining payments except the trial entry fee which are unpaid by the deadline, an owner may re-

If you do not comply you will forfeit your 2022 Award Distribution checks in November!!

But remember the horse is **NOT** an official New Mexico Bred & **CANNOT** run in a NM Bred race until the certificates have been finalized. (AQHA papers stamped in our office/ Jockey Club papers "stamped" online)



EXPORTING BROODMARES

All foals MUST BE conceived and born in NM to be eligible for NM Bred status.

If a registered NM Broodmare in foal to a registered NM Stallion leaves the state of New Mexico:

- The application and the \$500 fee must be postmarked no later than the deadline of October 1st of the breeding year.
- If the application and \$500 fee are NOT received by the applicable deadline, there is a ten day grace period and then the fee increases to \$1,000 for the foal to be eligible for NM Bred status.

EXPORT BROODMARE <u>RETURN FORMS BEGINNING WITH 2022 FOALS</u> ARE NO LONGER REQUIRED!

You must still fill out the Export Form and pay \$500 per mare by October 1!

MARES CONSIGNED TO A SALE

- No fees are required if the mare is consigned to an advertised sale out of the State of NM if the form is completed and returned to the NMHBA.
- The mare may then leave NM seven (7) days prior to the sale and must return to NM no later than seven (7) days after the completion of the sale for the foal she is carrying to maintain eligibility for NM Bred accreditation.
- If the Broodmare is not returned to NM after a sale, a grace period of ten (10) days will be granted for the \$500 Export Broodmare Registration fee to be paid for the foal to be eligible for NM Bred status.

The seller or buyer must notify the New Mexico Horse
Breeders Association on the status of the broodmare
in foal within seven days after the completion of the
sale for the foal she is carrying to maintain eligibility
for accreditation.
