QUALIFICATIONS FOR ARIZONA BREDS TO RUN IN NEW MEXICO BRED / ARIZONA BRED RACES

- **Only Thoroughbreds are eligible for this program.**
- **Must be a registered New Mexico Bred, or a registered Arizona Bred (must be by a stallion that stood in Arizona) to qualify.**
- **Arizona Bred owners must become members of the New Mexico Horse Breeders Association.**
- **Arizona Breds must sign up with the New Mexico Horse Breeders Association and pay a yearly fee of \$1,000.00 per horse. This fee is due January 1st or before entering into a Thoroughbred New Mexico Bred / Arizona Bred race. Eligibility will expire every December 31st each year no matter when the \$1,000.00 fee was paid.**
- **Arizona Bred horses will be eligible to run for the gaming portion of the New Mexico Bred purse money only. There will be no Incentive Awards, or 10% Awards paid to Arizona Breds.**
- **Arizona Breds will be eligible to run in overnight Thoroughbred New Mexico Bred / Arizona Bred races or in Thoroughbred New Mexico Bred Stakes, but New Mexico Breds will be preferred over Arizona Breds for eligibility in stakes races.**
- **This program will have to be approved by the Board of Trustees of the New Mexico Horse Breeders Association each year.**
- **This program will sunset after 3 years in 2028.**
- **A 2026 foal from an Arizona registered mare bred to a New Mexico Stallion will be eligible to be in the 2027 New Mexico Bred sale. Broodmares need to be registered with the NMHBA by September 1st of the year bred. These mares can foal out of state if the owner of the mare chooses to do so but would have to be enrolled in the Export Broodmare Program and pay the \$500 fee plus the \$500 foaling out of state fee.**
